PURCHASE AGREEMENT OF PET PUPPY

The following agreement is between Jennifer Wehking, hereafter referred to as “Breeder” and hereafter referred to as “Purchaser” for the sale and purchase of one purebred dog of the “Cavalier King Charles Spaniel” breed.

In consideration of a purchase price of \$_____, the breeder transfers all responsibilities associated with the ownership of a _____ dog of the Cavalier King Charles Spaniel breed to Purchaser as of this date,_____. This represents the entire agreement between Breeder and Purchaser in an outright or co-ownership sale.

USE OF THE DOG

It is agreed between Breeder and Purchaser that this dog is being acquired as a family companion animal to be used for tasks appropriate to its breed such as therapy dog or obedience and or conformation competition.

We agree that the dog is not purchased for resale nor will it be used or trained for activities which are illegal or for which it is not suited by reason of temperament or conformation.

OWNERSHIP RESPONSIBILITIES

The Purchaser agrees to maintain the dog in a home environment and properly train and care for it. Specifically , the dog will be properly licensed and inoculated against rabies, distemper, parvovirus, and other communicable diseases as recommended by a qualified veterinarian. The Breeder strongly recommends permanent identification .

HEALTH

The breeder warrants the dog to be in good health and free from parasites at the time of sale. Said dog has been cleared as healthy by Breeder's veterinarian prior to purchase. Further, Breeder warrants that both the sire and dam have been checked and cleared for breeding by a veterinary cardiologist against Mitral Valve Disease.

In the event of emergence of any genetic disorder which is sufficiently serious in the opinion of two qualified veterinarians, one of whom selected by the Breeder, to render the dog unsuitable as a pet, the Breeder agrees to replace the dog with one of equivalent quality as soon as one becomes available within the first three years of said dogs life.

Breeder requires Purchaser to have the dog seen by a veterinarian of Purchasers choice within 48 hours of picking up the dog. A full refund of purchase price will be refunded for any dog failing a veterinary exam during the first 48 hours.

OWNERSHIP RESPONSIBILITIES

The Purchaser agrees to maintain the dog in a home environment and properly train and care for it. Specifically , the dog will be properly licensed and inoculated against rabies, distemper, parvovirus, and other communicable diseases as recommended by a qualified veterinarian. The Breeder strongly recommends permanent identification .

SPAY & NEUTERING

Any puppy purchased as a family companion and judged not to be of show and breeding quality as determined by Breeder will be altered before one year of age. A copy of the attending veterinarian's surgical procedure will be forwarded to Breeder upon completion.

RIGHT OF RECOVER/PLACEMENT

In the event that the Purchaser is unable to keep said dog or provide an appropriate home in accordance with this agreement, said dog will be returned to the Breeder. Purchaser agrees to notify the Breeder if any such contingency arises and will not abandon said dog to a shelter , sell , or give the dog away. If said dog is found to have been sold or given away without Breeder's written consent and the Breeder discovers this, the Breeder will take legal action and original Purchaser of said dog will be responsible for all legal expenses incurred.

REGISTRATION

The Breeder certifies that said dog is eligible for registration under the Regulations of the American Kennel Club as a purebred Cavalier King Charles Spaniel and will provide the proper forms for such a registration upon receipt from the AKC. The Breeder reserves the right to affix the kennel name "St Jon" and supply a registry name for the dog. Any dog purchased as a pet will be sold with a limited registration unless stated in the special provisions section of this agreement.
